Place the primary receptacle and the secondary packaging, (plastic bag), inside the container for a safe and effective means of transportation on the public highway. This works equally well for healthcare professionals in the community or hospital staff transporting samples to the laboratory. By utilising the same type of container in both hospital and community settings avoids any confusion of different practices.

The 30 litre container is designed for larger collections from clinics, surgeries ect. to be carried on the public highway to the local hopsital or laboratory for analysis. This is ideal for transport departments or carriers offering this type of collection service.
